







## Warm Homes Discount Scheme

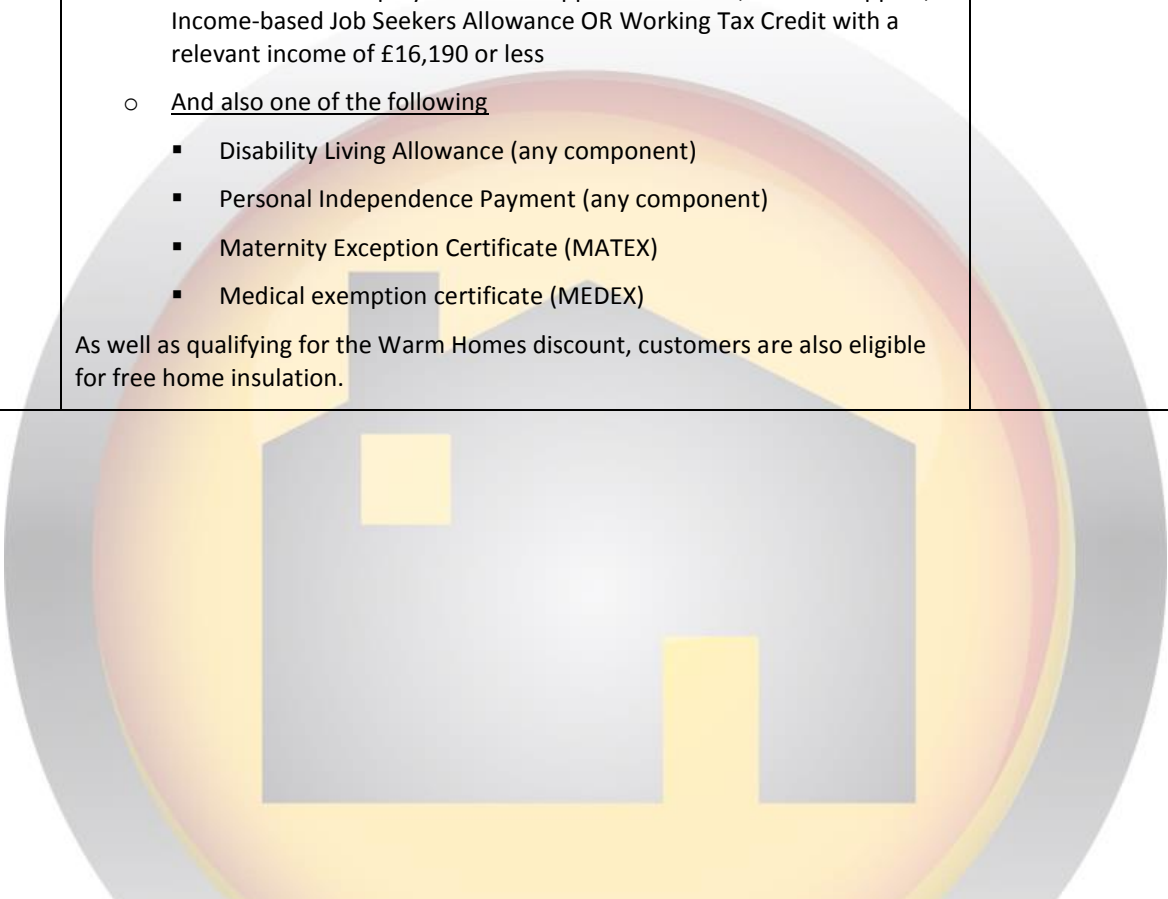
**Rebate schemes are a fixed amount of £140 for electricity accounts only, pre-payment meter customers will receive a rebate as a credit on their key**

**\*\*Core Group** – If you receive the Guarantee Credit element of Pension Credit the rebate will be automatically added to your electric account if your supplier is part of the scheme
